BOOK PROJECT: EXPORTING BORDERS

In my book project, I show how the U.S. Department of Homeland Security (DHS) intruded into Mexican territory, where it tested and refined a system of extraterritorial administration, systematically integrating Mexican federal institutions into active yet subordinate roles under U.S. federal command. By tracing the DHS's intrusions and situating them within the historical context of U.S. interventions in Latin America and the Caribbean, I connect U.S. border externalization to developments in the American imperial state. Likewise, I situate developments in the Mexican federal bureaucracy within the U.S.-Mexico transnational hierarchy. I explain the hemispheric and global implications of U.S.-Mexican transnational repression capabilities.
